# **Environmental and Social Policy**

#### **Preamble**

The system for integrating environmental and social (E&S) aspects in Shubham Housing Development Finance Company Ltd. (Shubham) business operations has been developed in two parts:

- Part I: Environmental and Social Policy
- Part II: Environmental & Social Management System

The E&S Policy document as Part I of the documentation presents the E&S Policy Statement of Shubham that translate the Policy to action. The Policy states Shubham's intentions on environmental and social aspects of the business. This Policy document may be circulated with Shubham's stakeholders.

The Environmental & Social Management System (ESMS) presented in Part II of the documentation has been developed to enable implementation of the E&S Policy. The ESMS Manual articulates the operational procedures to be adopted by Shubham for each transaction. The ESMS is an operational level document, that may need to be adapted in future and will remain internal to the Company.

# 1 Introduction

## 1.1 About Shubham Housing Development Finance Company Ltd.

Shubham Housing development Finance Company Limited ("Shubham" or "Company") is a leading provider of housing finance established in 2010 and headquartered in Gurgaon, India. Shubham caters to Urban and Semi-urban segment that consists of rural, self-employed, and micro entrepreneurs. With the growth of Indian economy and urban migration, real estate rates have risen, and affordability has declined. Through its product portfolio, Shubham strives to address this gap and drive financial inclusion for this underserved segment. It offers affordable and customised housing finance solutions to those with informal incomes through new age credit programs.

Shubham's loan products include home loans and loan against property.

# 2 Background to E&S Policy

Shubham recognises that activities of its borrowers have the potential to cause both adverse and beneficial Environmental and Social (E&S) impacts. In order to achieve its vision of being the preferred mortgage lender for families with informal incomes, the Company realises the need to address these E&S risks and impacts in a structured manner and take measures and initiatives at the appropriate stage.

These adverse impacts, if left unaddressed, could translate to credit risks and/or reputation risks for Shubham in the long run. There are also opportunities through downside risk management and upside value creation. This can help in brand differentiation, portfolio performance in terms of impact creation, stronger client relations, and increased loyalty.

Cognizant of this need, Shubham has developed an E&S Policy that states its commitment to integrating E&S considerations in its business operations. The E&S Policy has been developed in alignment with the national E&S laws and regulations and relevant E&S Good International Industry Practices (GIIP) and Investor's E&S Safeguards.

## 3 Reference Framework

The E&S Policy for Shubham has been developed with reference to the following frameworks:

- Good International Industry Practice (GIIP) requirements as applicable:

Based on the consideration of all above frameworks, Shubham has developed its E&S Management System (ESMS) that is aligned to all above. The ESMS will follow an exclusion list as described in Annex 1 that is in line with the above reference framework.

For all loan transactions, the ESMS will be implemented in compliance to Indian regulations. However, in cases where international E&S safeguards listed above are applicable and there is a difference between Indian regulations and international E&S safeguards, more stringent of the two requirements would be adhered to.

The E&S aspects applicable to the Company's focus areas are covered in the above listed reference framework and presented in **Figure 1-1**.

# 4 Environmental and Social Policy Statement

The E&S Policy of Shubham underlines its aspirations as well as commitment towards integrating E&S considerations in its transactions.

On disbursement, environmental and social monitoring will be carried out. In addition. Shubham will proactively engage with the stakeholders ensuring timely resolution of grievances if any.

# 5 Other Supporting Policies

Shubham has several policies that support the environmental and social policy and these are available on its website (www.shubham.co).

The objective of this code is to ensure that Shubham provides quality service and maintains transparency in its operations.

# 6 E&S Policy Implementation Arrangement

### 6.1 Approval

The E&S Policy have been formally approved and adopted by the Board of Directors at Shubham. The policy will be applicable to all loans extended by the Company from the date of approval.

#### 6.2 Communication

The E&S Policy have been communicated to all employees through suitable training programs (induction and refresher) and communicated to other stakeholders, such as investors, borrowers, as relevant.

The E&S Policy have been disclosed to all stakeholders of Shubham through its website.

# 7 E&S Policy Implementation

Shubham has developed an ESMS to support implementation of the E&S Policy. The ESMS has been formally adopted by the Board and will be implemented in all loan transactions of the Company from the date of approval.

Under the ESMS, procedures for E&S risk identification, management and monitoring have been developed and supported by annexes and tools. The procedures have been mapped with the loan appraisal cycle of the company. The institutional structure with roles and responsibilities of various departments towards implementation of the ESMS has been outlined.

The E&S policy and its requirements will be audited as per existing internal audit processes of Shubham.

The E&S Policy will be reviewed and updated as required, at least once in three years, to ensure its adequacy, effectiveness, and suitability to the changing scenarios of environmental and social governance.

In case a need for revision in the E&S Policy is realized in the future, the revised policy document will need to be approved by the Board before its implementation.
